## what is **CYSTIC FIBROSIS?**

- Cystic Fibrosis (CF) is a genetic disease affecting approximately 30,000 children and adults in the United States.
- CF causes the body to produce an abnormally thick, sticky mucus, which clogs the airways and can lead to fatal lung infections.
- 10 million Americans, one in 28 people, carry one defective CF gene, which does not cause the disease or any symptoms. The disease develops when a child inherits two defective CF genes, one from each parent.

## who is **TRAVIS FERGUSON?**

**D**iagnosed with cystic fibrosis at 3 months, Travis' life was filled with interests like any boy - he was an avid and skilled fisherman, history buff and Nebraska football fan. His father, Doug, remembers Travis as **"Never asking for much, other than to live. He had a real desire to live."** Travis really enjoyed life, he tried not to let CF interfere.

Dr. Tom Osborne, former Nebraska head football coach, is joining the fight for the cure by being the honorary chairperson. Dr. Osborne's personal commitment with Travis and his family began in September 1998, while Travis was awaiting a double lung transplant. They had talked about a fishing trip after Travis regained his strength from the transplant. Unfortunately, Travis passed away in April, 1999 from complications. He had just turned 17.

### **OUTDOOR EVENTS/GATHERINGS**

Because of risks to people with cystic fibrosis (CF), individuals who have ever had confirmed positive sputum culture for Burkholderia cepacia (B. cepacia) complex shall not attend any Foundation events. These requirements are because CF germs can be passed between individuals who have CF. B. cepacia in a person with CF can cause serious respiratory illness and, in some patients may lead to death. CF germs are not a risk for otherwise healthy individuals. At any outdoor event, people with CF should keep at least 6 feet away from others with CF.

Despite this policy, individuals with CF might choose to attend events without informing the CF Foundation or without the Foundation's knowledge. If so, they do so at their own risk. The Foundation accepts no responsibility for any risk to health involved in attendance, or in any social contact between persons with CF. ## **condensed rules & REGULATIONS**

- 1) Failure to comply with any rule may result in disqualification.
  - 2) Entry fee is \$150 per 2-man team (\$75 per person based on a 2-person team).
  - 3) Any person 18 years or younger must be a team partner with a legal parent or guardian.
  - 4) At least one team member or representative must check-in at registration and be present at the rules meeting at 6:20am the morning of Saturday, August 6th, Failure to attend or send a representative to the pre-tournament meeting will result in disqualification. The tournament will begin at 7am, Saturday, August 6th and end at 2:30pm.
  - 5) All teams are subject to a boat inspection during the tournament. All boats entered in the tournament must carry a \$100,000 liability policy with them at all times during practice and the tournament.
  - 6) Teams must come to the official weigh-in site and slips must be signed by one partner to verify weight. Teams must check-in by the official time or are disqualified.
  - 7) In case of a tie, positions shall be resolved by drawing or as decided by the tournament director.
  - 8) All state and/or lake rules apply.
- BAG LIMITS** — Five (5) fish per team with a minimum length of 15" measured on a Golden Rule™ flat board.
- All rules and regulations concerning the tournament will be issued during the official registration and meeting period. Violation of any of the rules and regulations may result in immediate disqualification.**
