BOAT CHECK AT 5:00AM on tournament dates. Blast off time to be stated at pre-tournament meeting. Anglers are responsible for all other fees that may apply.

* Entry payout for this tournament is 80/20. (Boaters payback 5 places and Co-Anglers payback 2 places) Big Bass & Calcutta are 100% payback.

Anglers must provide payment, signed waiver form and proof of boat insurance (minimum Liability of \$300,000) with entry form.

Anglers and co-anglers will be awarded invitations to the 2020 TBF Nebraska Semi-Final Team based on accumulated points earned in their respective division.

The boat check includes: Throwable preserver, life vests, empty live well, fire extinguisher, and functioning kill switch.
