Anglers must provide payment, signed waiver form and proof of boat insurance (minimum Liability of \$300,000) with entry form.

Anglers and co-anglers will be awarded invitations to the 2021 TBF Nebraska Semi-Final Team based on accumulated points earned in their respective division.

The boat check includes: Throwable preserver, life vests, empty live well, fire extinguisher, and functioning kill switch.
