Anglers are responsible for all other fees that may apply.

Anglers must provide payment, signed waiver form and attest to boat insurance (minimum Liability of \$300,000) with entry form.

Top 3 Anglers and co-anglers from each day will be awarded invitations to the 2023 TBF Nebraska Semi-Final Team.

The boat must have: Throwable preserver, life vests, empty live well, fire extinguisher, and functioning kill switch and must abide by all TBF Nebraska rules, readily found on the TBF Nebraska website.
