A PROPERLY COMPLETED AND SIGNED OFFICIAL ENTRY FORM MUST BE RECEIVED BY THE, OR BEFORE THE APPLICATION DEADLINE DATE OF (12:00pm May 24 2024) TWO WEEKS PRIOR TO THE BEGINNING OF THE OFFICIAL PRACTICE DAY. ENTRIES RECEIVED AFTER THIS TIME WILL BE SUBJECT TO A \$25.00 LATE FEE AND MUST BE PAID IN CASH.

Off Limits Area; To be announced at the pre-tournament meeting. Registration-Rules-Draw Meeting; May 31, 2024. 6pm Springfield Ramp parking lot. Contestants must be off the water by 6 pm Friday, May 31, 2024.

Registration; 6:00 to 6:30 pm Rules; 6:30 to 7:00 pm

Order Out; 7:00 to 7:30 pm

Each contestant or contestant Representative (prior notification must be made to the Tournament Director) must check in with official TBFN Tournament staff at the time and place prescribed on the schedule of events. At the Pre-Tournament Check-In/Registration contestants must be present for order out draw.

IT SHALL BE EACH COMPETITOR'S RESPONSIBILITY TO CHECK THE SCHEDULE OF EVENTS FOR REGISTRATION TIME AND LOCATION OR OBTAIN THIS INFORMATION FROM THE TOURNAMENT DIRECTOR.

DURING THE OFFICIAL PRACTICE AND COMPETITION DAYS OF THIS TBF NEBRASKA TOURNAMENT, NO CONTESTANT MAY OPERATE A BOAT UNLESS THAT CONTESTANT HAS A MINIMUM OF \$300,000 BOATING LIABILITY INSURANCE. THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRETOURNAMENT PRACTICE OR THE TOURNAMENT.

Requirements for Registration;

South Dakota Parks Pass, TBD.
Current Boat Registration
Current Boat Insurance
Current Nebraska Fishing License
Current South Dakota Fishing License

Limit: 5 Bass per team.

12 inch minimum, smallmouth, largemouth and spotted bass.

BOAT CHECK AT 4:30AM on tournament dates.

Blast off time to be stated at pre-tournament meeting.

Tournament hours are safe light to 3:00 P.M.

Anglers are responsible for all other fees that may apply.

- Entry payout for this tournament 85% payback after \$10 is taken out to help fund national team travel
- Big Bass paid back at 100%

Anglers must provide payment, signed waiver form and attest to boat insurance (minimum Liability of \$300,000) with entry form.

Top 3 Anglers and co-anglers from each day will be awarded invitations to the 2024 TBF Nebraska Semi-Final Team.

The boat must have: Throwable preserver, life vests, empty live well, fire extinguisher, and functioning kill switch and must abide by all TBF Nebraska rules, readily found on the TBF Nebraska website.
