THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.

Boat Insurance Nebraska Fishing License

Limit: 5 Bass per team.

15 inch minimum, smallmouth, largemouth and spotted bass. No culling or grading up. Only one bass over 21 inches permitted.

Side pots are encouraged but will not be set, collected or awarded by anyone deemed a Tournament Official.
