A PROPERLY COMPLETED AND SIGNED OFFICIAL ENTRY FORM MUST BE RECEIVED BY THE TBFN PRESIDENT ON OR BEFORE THE APPLICATION DEADLINE DATE OF **12:00 P.M. THURSDAY May 29, ONE WEEK PRIOR TO THE BEGINNING OF THE OFFICIAL PRACTICE DAY. ENTRIES RECEIVED AFTER THIS TIME WILL BE SUBJECT TO A \$50.00 LATE FEE AND ENTRY MUST BE PAID IN CASH.**

The Tournament waters shall be off limits to all competitors commencing at 12:01 am. **MONDAY JUNE 2 THE WEEK OF THE TOURNAMENT**, until safe light on the first practice day, **June 5, 2025.**

Contestants must be off the water by 2:00 p.m. on Friday June 6 2025.

Each TEAM or Team Representative (prior notification must be made to the Tournament Director) must check in with official TBFN Tournament staff at the time and place prescribed on the schedule of events.

At the Pre-Tournament Check-In/Registration Teams will participate in rules/out draw.

IT SHALL BE EACH COMPETITOR'S RESPONSIBILITY TO CHECK THE SCHEDULE OF EVENTS FOR REGISTRATION TIME AND LOCATION OR OBTAIN THIS INFORMATION FROM THE TOURNAMENT DIRECTOR.

DURING THE OFFICIAL PRACTICE AND COMPETITION DAYS OF TBFN TOURNAMENT, NO CONTESTANT MAY OPERATE A BOAT UNLESS THAT CONTESTANT HAS A MINIMUM OF \$300,000 BOATING LIABILITY INSURANCE. THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.

Requirements for Registration;

Boat Insurance

Missouri Fishing License

Limit: 5 Bass per team.

12–15-inch slot limit. Slot fish must be returned to the water immediately. Bass must be over 15 inches, smallmouth, largemouth and spotted bass.

Side pots are encouraged but will not be set, collected or awarded by anyone deemed a Tournament Official.

This Tournament will Qualify 3 Teams for the 2025 National Semi Finals.
