A PROPERLY COMPLETED AND SIGNED OFFICIAL ENTRY FORM MUST BE RECEIVED BY THE TBFN PRESIDENT ON OR BEFORE THE APPLICATION DEADLINE DATE OF **6:00 P.M. MONDAY APRIL 6, 2026, THE MONDAY PRIOR TO THE BEGINNING OF THE FIRST OFFICIAL PRACTICE DAY. ENTRIES RECEIVED AFTER THIS TIME WILL BE SUBJECT TO A \$50.00 LATE FEE AND ENTRY MUST BE PAID IN CASH. ENTRY FEES FOR THIS EVENT ARE \$250 PER TEAM.**

The Tournament waters shall be off limits to all competitors commencing at 12:01 am. **MONDAY APRIL 6, THE WEEK OF THE TOURNAMENT**, until safe light on the first practice day, **APRIL 9, 2026.**

**Contestants must be off the tournament waters (3 Mile or Icaria) by 2:00 p.m. on Friday April 10.**

DURING THE OFFICIAL PRACTICE AND COMPETITION DAYS OF TBFN TOURNAMENT, NO CONTESTANT MAY OPERATE A BOAT UNLESS THAT CONTESTANT HAS A MINIMUM OF \$300,000 BOATING LIABILITY INSURANCE. THIS DOCUMENTED PROOF MUST SHOW AN EFFECTIVE DATE AND EXPIRATION DATE AND MUST BE MAINTAINED IN THE COMPETITORS BOAT. THE PROOF OF INSURANCE AND A CURRENT COPY OF THE BOAT REGISTRATION WILL BE MADE AVAILABLE AT THE REQUEST OF ANY TOURNAMENT OFFICIAL AT ANY TIME DURING THE OFFICIAL PRE-TOURNAMENT PRACTICE OR THE TOURNAMENT.
